

# Auditory Hallucination Simulation

The **Auditory Hallucination Simulation (AHS)** is a powerful exercise that simulates what it is like to have auditory hallucinations. It was created to help promote understanding and empathy for those experiencing mental health disorders.

Empathy-based training is a powerful tool to allow individuals to step into the shoes of someone who is living with a specific indication. The STARR Coalition has created the Auditory Hallucination Simulation in which participants can experience one symptom associated with brain disorders: auditory hallucinations.

During the simulation, the participant is asked to complete simple, common tasks while pre-recorded 'voices' play in earphones. The recording was produced after interviewing dozens of individuals living with schizophrenia. They discussed their voices, common themes around their hallucinations, and details which were captured to create an authentic experience.

This Auditory Hallucination Simulation changes the conversation around the complexities of living with mental illness. Each participant will take something different away with them, but the empathy-based, personcentered experience will leave a lasting impression and perhaps change the trajectory of how we work, treat, and care for people living with mental illness.
